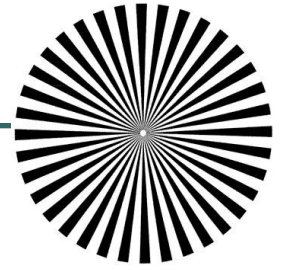

## Focus on: Libraries' Projects



University Libraries is leading a project to create a digital library, *Baoku* (“treasure trove” in Chinese). In collaboration with the Confucius Institute at George Mason University, this digital collection intends to provide K-12 social sciences teachers with teaching and



learning objects and materials about China and Chinese civilization. Still in its very early stages, the project aims to populate the digital library not only with materials about China, but also resources (such as photographs, videos and data) that would enable teachers to make comparative “connections” with parts and contemporaneous historical periods of the western world in teaching and learning about China. The collection’s focus is to target K-12 learning standards; communications and coordination with surrounding school districts (Fairfax, Arlington, Prince William, and Loudoun) is also in progress.

Coordinated by **Andrew Lee**, Humanities and Social Sciences Liaison Librarian, Johnson Center Library, the Baoku Project development team encompasses several library staff from various departments: **Nathan Putnam**, Head, Cataloging & Metadata Services Department, **Wally Grotophorst**, Associate University Librarian/Digital Programs & Systems, and **Andrew Smith**, Graduate Research Assistant, Fenwick Library Reference Department. [Omeka](#) is the technical platform selected for the [Baoku digital library](#). The Libraries’ team is also researching possible funders for the project, and the Office of the University Librarian and the Confucius Institute are assisting with related endeavors.

## Mason History Project

In late Spring 2012, George Mason University will celebrate its 40th anniversary as an independent institution. University Libraries’ Special Collections and Archives (SC&A) department is preparing for this important milestone by developing a digital history of George Mason University.

Dedicated funding for this endeavor was obtained from three sources:

- a gift of \$1,000 from Mason’s Osher Lifelong Learning Institute (OLLI) to support a student award
- a grant of \$20,000 by Mason’s Auxiliary Enterprises Management Council, and,
- \$1,000 supplemental funding from the University Libraries’ budget for special projects.

Mason History Project activities are coordinated by **Bob Vay**, Digital Collections Archivist, with other SC&A staff contributing to the effort. **Joanna Lee**, Digital Repository Services Librarian, is developing the digital site for the project. Mason student assistants have been selected and trained to assist with the development in a paid “internship” capacity. The Mason History Project will be unveiled on April 15, 2012.

- **Anne Driscoll**, Education Liaison Librarian, to complete an article on the *Books in Print* database, which was accepted for publication by *Reference Reviews*.

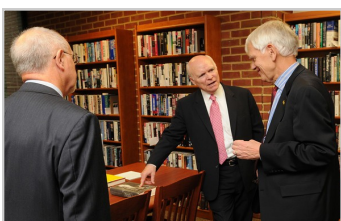


## Exhibits & Events

On September 21, 2011, “**An Evening with Brian Lamb: Celebrating Ideas, Authors & Books**” marked the generous donation to the University Libraries from Brian Lamb, C-SPAN founder and chief executive officer, in conjunction with C-SPAN as well as financial support from its educational foundation.

### EXHIBIT

*Booknotes*, created and hosted by Mr. Lamb, was broadcast on C-SPAN from April 1989 through December 2004. It proved to be a popular television forum for writers of history, biography, politics, and public affairs.



The *Booknotes* collection consists of 801 books which Mr. Lamb read for the hour-long weekly program. Many of the titles in the collection contain extensive marginalia, and other notes, made by Mr. Lamb as he prepared for his one-on-one interview with each author.



A special exhibit, “Beyond the Book: An Exhibit of the Brian Lamb *Booknotes* Collection” was prepared by Special Collections & Archives, and is on display until January 2011, Fenwick Library, 2<sup>nd</sup> Floor, Wings A, B and C. The exhibit highlights both the *Brian P. Lamb Booknotes Collection*, donated to the University Libraries by Mr. Lamb in April 2011, as well as the interviews he conducted with each book’s author. A [digital exhibit](#) complements the larger physical display.

### RECEPTION & REFLECTIONS



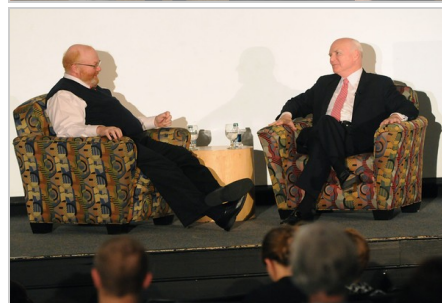
Fenwick Library hosted a well-attended reception for the occasion. After touring the exhibit, and greeting the assembled guests, remarks were made by John Zenelis, University Librarian; Mason President Alan Merten, and Brian Lamb.

Following the reception, Mr. Lamb, currently host of the Q&A interview series on C-SPAN, and Richard Norton Smith, Mason Scholar-in-Residence, reflected on the *Booknotes* series at an event held in the Johnson Center Cinema. Approximately 150 people attended the discussion, which focused on the craft of writing and authorship. The entertaining discussion, followed by questions from the audience, was enlightening and educational.

## 2011-12 Fenwick Fellow

The Fenwick Fellow for the 2011-2012 academic year is **Dr. Jesse Guessford**, Assistant Professor, School of Music, College of Visual and Performing Arts. Dr. Guessford's research project, "John Cage and Henry Cowell's New Musical Resource", sets out to find the source of the compositional procedures and techniques used by John Cage between the years 1933 and 1951.

Professor Guessford expects that through this research, he will find a common relationship between the techniques used by Cage and those detailed by Cowell. He plans to eventually complete two publications: the first, an extensive journal article highlighting the links between the works of Cage and Cowell's publication; the second, a book extensively analyzing John Cage's works between 1933 and 1951.

The annual Fenwick Fellow program assists research by Mason faculty members as well as enhances the collections of the University Libraries. The fellowship provides a \$5,000 award for research materials and assistance, along with an office in the Fenwick Library, to support the research project. Conducted each spring, the competition is open to all tenured and tenure-track faculty members at George Mason.

## Mason Award Presented to Stephen King

The University Libraries was again a visible sponsor of the *Fall for the Book* festival, September 18-23, 2011. The concluding highlight of the festival was the presentation of the Mason Award to prominent and bestselling author **Stephen King**, on September 23 at the Concert Hall of the Center for the Arts, Fairfax Campus. The ticketed, and, full-house event, in which the author spoke and answered questions by the audience, was co-sponsored by the University Libraries and the Mystery Writers of America.

## University Libraries Acquires Library of Kenneth W. Thompson

Through a generous gift, the collection of famed academic and author, Kenneth W. Thompson was donated to the University Libraries. Thompson served as the director of the [Miller Center for Public Affairs at the University of Virginia](#) (1978-98), vice president for international programs at the Rockefeller Foundation (1955-75), and taught political science and international relations at the University of Chicago, Northwestern University and the University of Virginia.

The library of some 5,700 items includes approximately 3,000 monographs covering world history, international relations, diplomatic relations, military history, law, the American presidency, espionage, international education, the Cold War, and the Soviet Union. 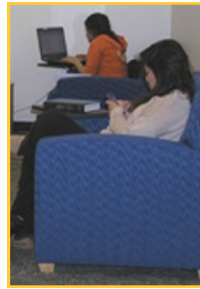

## Learning Commons@Johnson Center Library

Beginning in late Spring 2011, and throughout the summer, staff in the Johnson Center Library, Administrative Services Department, Systems Group, and the Office of the University Librarian collaborated on planning, design and implementation of



a prototype Learning Commons on the Second Floor (enclosed part) of the Johnson Center Library. With abundant and varied technology, in addition to different types of fixed and movable furniture, an inviting and highly conducive space for student collaborative and individual learn now exists in approximately 13,000 square feet of space.



Already well into the Fall 2011 semester, usage statistics indicate the Learning Commons is a very popular undergraduate student destination in the Johnson Center Library. This prototypical learning environment provides a living lab to observe, and learn about, student research and learning behaviors, and usage patterns. The practical experience gained here will inform future plans as we seek to transform the role of the entire Johnson Center Library in the years to come.
